INTRODUCTION

With the EU Regulation 679/2016, laying down provisions for the protection of natural persons, with respect to the processing of personal data, IGM Resins Italia Srl, based in Corso Magenta 82, Milan (hereinafter referred to as "organization"), as the Data Controller, represented by its pro tempore legal representative, is required to provide some information about the use of personal data.

#### DATA SOURCE AND TYPES OF PROCESSED DATA

Personal data acquired by the organization can be collected

- directly from data subject

(by delivering a hard copy of one's *curriculum vitae* and/or by applying through the company website). In the event of an application to a specific position or in the case of spontaneous application through the e-mail address available on the company website one's *curriculum vitae* and the personal data contained therein could potentially be viewed by the HR managers of the organization.



IGM Resins Italia S.r.l. will process the personal data of the data subject exclusively in compliance with the provisions of EU Regulation 679/2016 and the Italian privacy legislation in force or Legislative Decree 196/2003, as amended by Legislative Decree 101/2018, and in any case for the purposes and in the manner described in this disclaimer.

For the data not directly collected from the data subject, this disclosure is provided at the time of their registration and however, no later than the first possible communication.

The processed data is personal data (eg name and surname, address, telephone number, e-mail address, etc.) and possibly particular data (eg, membership of protected categories, registration with trade unions, etc.).

In particular, as part of the staff selection process, the organization may be in possession of data that the law defines as "sensitive", ie those from which it may possibly be deduced, among other things, the racial and ethnic origin, religious convictions, political opinions, membership of parties, trade unions, religious or philosophical, political or trade associations or organizations, as well as the state of health.

In any case, all this data is processed in compliance with the aforementioned law and with confidentiality obligations to which the organization's activity has always been based.



#### DATA CONSERVATION PERIOD

The data is kept only for the period necessary for the selection purposes for a specific position and, subject to optional consent, also for future positions of potential interest and in any case in accordance with national and EU laws, rules and regulations to which the organization must follow. It is expected that a periodic check will be carried out annually on the data processed and on the possibility of being able to cancel them if no longer necessary for the intended purposes. The specific curricula vitae will be safely destroyed if they are not considered more current or interesting, after a minimum period of 12 months after which, any return will not be possible.

#### DATA PROVISION AND CONSEQUENCES IF NOT PROVIDED



The provision of data must be considered mandatory, with regard to the processing that the organization must carry out to meet the needs of knowledge and evaluation of candidates in the field of research and selection of staff, for the coverage of job positions, as well as legal obligations, rules, regulations. Failure to provide such data may make it impossible for the organization to initiate the process of research and selection of personnel.

#### PURPOSES OF THE DATA PROCESSING

The data is processed within the normal activity of the organization and for the following purposes. If the Data Controller intends to further process the personal data for a different purpose than that for which It was collected, he will beforehand provide to the data subject all necessary information and will proceed to request the consent where required.

Search and selection of personnel to be included within the organization for a specific position or after a spontaneous application, including the purposes of related legitimate interest or administrative obligations carried out for the purpose of public institutional character, the transposition and management of obligations provided for by laws, regulations and national and EU legislation, as well as by provisions issued by authorities legitimated by the law and by supervisory and inspection bodies.

### LEGAL BASIS OF DATA PROCESSING

#### RIGHTS OF THE DATA SUBJECT

To guarantee the correct exercise of the rights, the data subject must be identifiable in an unequivocal manner. The organization agrees to provide feedback within 30 days and, if it is impossible to meet these deadlines, to justifying the possible extension of the deadlines. The response will be free of charge except in cases of groundlessness (eg there is no data concerning the applicant data subject) or excessive requests (eg repetitive over time) for which a fee may be charged no higher than the costs actually incurred for the research carried out in the specific case. The rights related to personal data concerning deceased persons may be exercised by those who have an interest of their own or act to protect the data subject or for family reasons deserving protection. The data subject can also submit a complaint to the supervisory authority. In case of violation of personal data suffered by the organization, the Data Controller will proceed to notify the competent supervisory authority within 72 hours of the occurrence and will also communicate the event to the data subject, except in cases of exclusion provided for by law.

THE DATA SUBJECT HAS THE RIGHT TO REQUEST: access, rectification, deletion of personal data, limitation of processing, as well as data portability. THE DATA SUBJECT HAS THE RIGHT TO TAKE POSITION AGAINST: the data processing and to revoke the consent at any time without prejudice to the lawfulness of the processing based on the express consent before the revocation.
